VIETNAM: Montagnard Church Leader Sentenced to Imprisonment

On August 5th, a court in Vietnam's Dak Lak province sentenced Pastor Y Nuen Ayun to seven years and six months in prison for "undermining the policy of national unity." Communist officials claim that he has been organizing and leading unregistered religious activities since 2003. Pastor Ayun, whose ethnicity originates with the Montagnards, ministered to others belonging to this indigenous group through his pastoral leadership at the Central Highlands Evangelical Church of Christ.

According to reports made by Vietnam's state media, Pastor Ayun had associated with A Ga, a Vietnamese pastor presently residing in the United States, who helped establish the Central Highlands church. Communist officials allege that Pastor Ga advocates for separatist movements within this particular geocultural subregion of Vietnam and have classified him as a terrorist.

Following Pastor Ayun's arrest in October 2025, prosecutors stated during his trial that he was "aiming to abet hostile forces against the people's government." The subsequently issued indictment specified that the Montagnard pastor "established and operated a church, propagated and developed followers; participated in and organized [their] fellowship on the Internet and in person at church group meetings." The defence argued that none of these actions equated to opposition against the government.

Most of Vietnam's Christians are ethnic minorities residing in the country's highlands. Communist officials frequently fabricate charges to oppress believers within this subregion, particularly those belonging to the minority groups. SYRIA: Visiting Lebanese Pastor Released from Detainment

Nihad Hassan is a Kurdish pastor living in Beirut, Lebanon. On various occasions, he has expressed concerns over the difficulties encountered by the Kurdish people in Syria, particularly those who have converted from Islam. Syrian authorities claim that the Lebanese pastor's social media comments were offensive. Consequently, he was arrested on July 20th while visiting family in Afrin, a city located in northern Syria that primarily consists of Kurdish people.

Thankfully, Pastor Nihad was released from custody on August 3rd. At the time of his release, the authorities advised him to return to Lebanon, which he compliantly did. Presently, he is prioritizing the well-being of his children, who were traumatized by the recent arrest. Since the incident, every time he now leaves home, his fearful young daughter cries out, "Daddy, don't go to the police!"

Observers have noted an apparent increase in hostility towards Christians – not only from Syria's governing officials but also others in the country who oppose Christianity. Since the fall of Bashar al-Assad's government, the previously provided protections of believers have been at risk. Further exacerbating this concern is the notable increase of militant Islamic influences throughout the country. INDONESIA: Sentencing of Christian Accused in Blasphemy Case

Earlier this year, Dedi Saputra allegedly posted a video on TikTok that criticized the prophet Muhammad. Before the video was removed from the social media platform, it had been viewed almost two million times – sparking a backlash that culminated in his arrest on February 18th. On July 10th, a court in Aceh Province declared the convert from Islam guilty of blasphemy and hate speech. As a result, Dedi received a sentence of two years' imprisonment, which includes the time he has already served in detainment since his arrest. As prosecutors were originally demanding a longer prison term, there is the possibility that they may attempt to appeal the current sentence.

- *As Dedi patiently awaits his hopeful early release from detention, may he experience God's promised help, encouragement, protection and strength – along with opportunities to display the Lord's compassion to all those around him.*
- *In the interim, ask the Lord to also mediate judicially on his behalf, so that the prosecutors' attempts to extend Dedi's prison term will not prevail; instead, may this believer's sentence be substantially reduced.*
- *Pray that Christians throughout the island nation of Indonesia will continue boldly declaring the "Good News of the Gospel" in ways that bring both conviction and repentance, so many more lives can be transformed by God's sacrificial love and the eternal spiritual truths contained within His infallible Word.*
